CPOS BASICS

- Course Program of Study
- Enforcement process for the federal mandate that Title IV funds only be used for degree-applicable courses.
 - **Title IV funds** = federal loans, federal grants, federal work study
 - **Degree-applicable** = a course that fulfills a degree requirement
 - Degree applicability, in this context, is *not* a characteristic of the course itself but an assessment of how it fits into an individual student's degree plan.

KEY FACTS

- **Courses in Fallthrough are not degree-applicable for the purposes of CPoS.**
 - Advisors need to move things that should not be in Fallthrough ASAP.
 - *This will mean processing exceptions for In-Progress courses.*
- **CPoS does not look backwards in time.**
 - It doesn't matter what's in Fallthrough *from previous semesters*
- **12 degree-applicable credits is the threshold for Title IV aid to disburse at the full-time rate.**
 - Credits 13 and beyond do not have to be degree-applicable.



HOW TO TAKE A NON-APPLICABLE CLASS

- CPoS **denies Title IV funding** for non-applicable courses.
 - It does not forbid students from *taking* non-applicable courses...
- Title IV students can take non-applicable courses if at least one of the following is true:
 - They are *also* taking at least 12 credits of applicable courses.
 - They have a *non-Title IV* way of paying for the non-applicable course(s).



NON-TITLE IV FUNDING

- LIFE Scholarship
- Palmetto Fellows Scholarship
- SC Need-Based Grant
 - ***This is a change from our December presentation.***
- Departmental Scholarships
- General University Scholarships
- Private loans
- Private grants
- Any other non-federal funding



IDENTIFYING TITLE IV STUDENTS

- **Financial Aid is not legally permitted to tell advisors who the Title IV students are.**
 - But students may choose to self-identify.
 - And advisors may ask.



APPEALS AND ERRORS

- **There is no appeals process.**
 - Title IV will *not* pay for courses that are not degree-applicable.
- **If the CPoS info is incorrect...**
 - Process the appropriate exception in DegreeWorks.
 - Check the CPoS information in Self Service Carolina again tomorrow.



FORESEEN ISSUES

- **Students pursuing multiple degrees**
 - CPoS only considers the first degree.
 - Courses that are *only* applicable to the second degree should occupy credits 13-18 if possible.
 - The order of the degrees matters.
- **Students with pre-existing credit (AP, IB, DE, etc.)**
 - These students may not have four years of Title IV aid eligibility.
 - When they have enough credits to graduate, they must either graduate or find non-Title IV funding.



FORESEEN ISSUES

- **Pre-professional students**
 - Courses taken in preparation for grad school are not degree-applicable if they don't also fulfill a graduation requirement for the current degree.
- **Students studying abroad**
 - INTL placeholder courses are scribed as applicable for all degrees.
- **UNIV 101, ROTC, etc.**
 - These are also scribed as applicable for all degrees.



FORESEEN ISSUES

- **Students taking pre-requisites to required courses.**
 - The pre-req is only applicable if it is listed as a degree requirement.
 - Units may want to edit Bulletin entries to list hidden pre-reqs in degree requirements. (e.g. MATH 111)



FORESEEN ISSUES

- Students repeating courses
 - A student may repeat a course as many times as necessary as long as no grade of D or higher exists.
 - After a grade of D or higher exists, the student may repeat the course once.
 - A student who needs to repeat a course they have AP credit for may do so once.
